<ol> <li>You or Your waiving Dependents were covered under another dental plan at the time of waiver, you are no longer covered under the other dental plan for one of the reasons stated below and you request enrollment in Premier within 30 days after termination of coverag or Employer contribution under the other dental plan.</li> </ol>
<ul> <li>a. Termination of employment;</li> <li>b. Change in employment status;</li> <li>c. Termination of the other plan's coverage;</li> <li>d. Cessation of an employer's premium contribution toward an employee's or dependent's coverage; or</li> <li>e. Death of or divorce from the individual through which the waiving individual was covered as a Dependent.</li> </ul>
<ol><li>A court orders coverage be provided for a spouse or child of an insured Employee and request for enrollment under Premier is mad within 30 days of the issuance of the court order.</li></ol>
